Our First Principle and Strategic Imperative



Reported Net Income (C\$ millions)





Adjusted Diluted Earnings Per Share(3) (C\$)





Return on Common Shareholders' Equity (%)





Loan Loss Ratio (basis points)




Business Highlights and Performance: Q2 2013

Revenue (C\$ millions)






Wealth Management
