

# Form of Collateral Mortgage Yukon Territory

To be used for Commercial Loans only

As collateral security and for the better securing of payment to Canadian Imperial Bank of Commerce ("CIBC") of the Indebtedness (in an amount not exceeding the Amount Secured) and performance of all other obligations under this Mortgage,

gives to CIBC, as mortgagee, the mortgage and charge described below:
