



## \$50 Offer for CIBC Best Student Life Bundle™

### Terms and conditions

This offer is governed by Canadian law. For the purposes of this Offer: “**you**” and “**your**” mean any Eligible Client(s); “**we**”, “**our**” and “**us**” mean Canadian Imperial Bank of Commerce; and “**Terms**” means these terms and conditions that govern this Offer.

#### 1. Offer

The *\$50 Offer for CIBC Best Student Life Bundle* (the “**Offer**”) begins on November 20, 2025, at 12:01 a.m. (ET) (“**Offer Start Date**”)¹. The Offer consists of a \$50 Cash Reward (the “**Cash Reward**”) for opening a CIBC Best Student Life Bundle, which consists of: a CIBC Smart Account with Smart Start or Smart for Students benefits, a CIBC eAdvantage Savings Account and a CIBC student credit card (each an “**Account**” and collectively, the “**Accounts**”) and completing the offer requirements set out below. The Offer is offered by Canadian Imperial Bank of Commerce (“**CIBC**”).

#### 2. Eligibility

This Offer is only open to residents of Canada and international students who as of the Offer Start Date: (i) have reached the age of majority in their province or territory of residence, (ii) are not a holder (or joint holder) of a CIBC chequing account or CIBC savings account or a primary cardholder of a CIBC credit card, and (iii) meet all other eligibility requirements applicable to each Account. Individuals who meet the foregoing eligibility requirements and otherwise comply with these Terms, as determined by CIBC at its sole discretion, may be referred to as “**Eligible Client(s)**”. This Offer can be combined with: CIBC Student Refer-a-Friend, CIBC Smart Start & Smart for Student cash reward offers, CIBC eAdvantage Savings Account special interest rate offers, and CIBC credit card cashback, Adapta Points, Aventura Points, or Aeroplan points welcome offers. This offer cannot be combined with any other offer, reward, or rebate unless otherwise indicated by CIBC.

#### 3. Offer requirements

To qualify to receive a \$50 Cash Reward, you must complete the following:

##### Step 1:

On or after the Offer Start Date, apply online through the CIBC Best Student Life Bundle application page or in a CIBC Banking Centre for the CIBC Best Student Life Bundle and open your first: CIBC eAdvantage Savings Account, CIBC Smart account with either the Smart Start or Smart for Student benefit, and a CIBC student credit card. A valid e-mail address must be provided as part of the application.

For Accounts opened through the CIBC Best Student Life Bundle online application, you must complete the opening of the applicable Account(s) at a CIBC Banking Centre if you are directed to do so in the online application.

##### Step 2:

By the end of the second full calendar month after the month the last Account in the bundle is opened (the “**Qualifying Month**”) and no later than four (4) months from the date of the first Account is opened, have a closing balance of least \$100 in each of your CIBC Smart account and your CIBC eAdvantage Savings account.

##### Step 3:

Maintain a month-end closing balance above \$0 for the next two calendar months following the Qualifying Month. Closing balances will be determined based on transactions that have been posted to your account on or before the end of the calendar month. In most cases, transactions completed after 6:00 pm ET or on weekends and holidays will be posted on the next business day.

For example, if you open your last Account in the bundle in July, you must have a closing balance of \$100 or more in your CIBC Smart account and CIBC eAdvantage Savings Account on September 30. You must then have a closing balance greater than \$0 in both of these accounts on November 30. The Cash Reward could be credited to your CIBC Smart account any time up to and including Jan. 31 of the following year.
