We begin charging interest for Balance Transfers and Convenience Cheques on the day they are posted. If we do not receive a payment for your full Amount Due on a statement, we may make your payment due date later on the next statement. This will give you extra time to make your payment, but we will continue to charge you interest during this extended period. When you pay your full Amount Due, we will change your payment due date back to its regular date.

## Merchant's Fees: Merchants may be charged higher fees for the acceptance of premium cards (Visa Infinite, Visa Infinite Privilege and World Mastercard).
