Management Discussion of Fund Performance

Investment Objective and Strategies

Investment Objective: CIBC Active Investment Grade Corporate Bond ETF (the *CIBC ETF*) seeks to generate a high level of current income while preserving capital by investing primarily in bonds, debentures, notes and other debt instruments of Canadian issuers.

Investment Strategies: The CIBC ETF invests primarily in Canadian investment grade corporate bonds based primarily on security selection, sector allocation, and average term-to-maturity. Portoflio assets are allocated to those securities and sectors of the corporate bond market that the portfolio advisor expects will outperform. The CIBC ETF undertakes a bottom-up analysis of corporate bond issuers combined with top-down analysis of a sector's potential in a given economic environment.

Risk

The CIBC ETF is a Canadian corporate fixed income ETF that is suitable for medium term investors who can tolerate low investment risk.

For the period ended December 31, 2024, the CIBC ETF's overall level of risk remained as discussed in the prospectus.

Results of Operations

The CIBC ETF's portfolio advisor is CIBC Asset Management Inc. (*CAMI* or the *Portfolio Advisor*). The commentary that follows provides a summary of the results of operations for the period ended December 31, 2024. All dollar figures are expressed in thousands, unless otherwise indicated.

The CIBC ETF's net asset value increased by 30% during the period, from \$1,240,928 as at December 31, 2023 to \$1,610,596 as at December 31, 2024. Net sales of \$330,678 and positive investment performance resulted in an overall increase in net asset value.

The CIBC ETF posted a return of 7.2% for the period. The CIBC ETF's benchmark, the FTSE Canada All Corporate Bond Index (the *benchmark*), returned 7.0% for the same period. The CIBC ETF's return is after the deduction of fees and expenses, unlike the benchmark's return.

Despite facing significant volatility, North American bond yields rose over the period. Economies continued to see progress in controlling inflation, albeit at a slower pace than previously expected. North American yields were also positively impacted by the U.S. election results and the potential for inflationary policies from the incoming administration.

At the start of 2024, futures markets anticipated five or six interest-rate cuts by both the U.S. Federal Reserve Board (the *Fed*) and the Bank of Canada (the *BoC*) for the year. However, these expectations changed in response to persistent inflation. The Fed lowered its federal funds rate three times in the second half of the year, ending the period at 4.25%–4.50%. The BoC cut its overnight rate five times, for a cumulative easing of 1.75%, reflective of a relatively weaker economy compared to the U.S.

The Canadian yield curve (defined as the difference in two-year and 30-year bond yields) steepened significantly in 2024. The majority of the move occurred in the second half of the year as the BoC began lowering interest rates. By the end of 2024, the yield curve had a positive slope, ending the year near +0.40%. In the U.S., the yield curve also steepened in the second half of the year, sitting close to +0.50% by the end of 2024.

Canadian bonds outperformed U.S. bonds, partly as a result of Canada's lower inflation levels and weaker economic activity. Corporate bonds outperformed as credit spreads (the difference in yield between corporate and government bonds with similar maturities) narrowed. This reflected strong demand for riskier assets and better-than-anticipated corporate profitability.

Overweight exposure to the real estate sector and the pipelines industry contributed to the CIBC ETF's performance. Underweight exposure to utilities also contributed to performance. Holdings in Royal Bank of Canada (5.01%, 2033/02/01), Brookfield Renewable Partners ULC (5.29%, 2033/10/28) and CT REIT (2.37%, 2031/01/06) contributed to performance. All three holdings outperformed on a relative basis.

Overweight allocations to the provincial, federal and municipal sectors detracted from the CIBC ETF's performance. The largest individual detractors from performance included holdings in Province of Alberta

(3.30%, 2046/12/01), Province of Manitoba (3.35%, 2043/03/05) and Enbridge Gas Inc. (3.59%, 2047/11/22). These holdings underperformed on a relative basis.

The Portfolio Advisor added new holdings in Videotron Ltd. (4.50%, 2030/01/15) and TransCanada PipeLines Ltd. (3.80%, 2027/04/05) based on their relatively attractive credit spreads. Existing holdings in The Bank of Nova Scotia (3.93%, 2032/05/03) and Manulife Financial Corp. (5.41%, 2033/03/10) were increased, also based on their relatively attractive credit spreads.

The Toronto Dominion Bank (2.67%, 2025/09/09) and Bank of Montreal (4.31%, 2027/06/01) were sold based on their relatively unattractive credit spreads. Rogers Communications Inc. (3.65%, 2027/03/31) was trimmed to increase the CIBC ETF's credit quality. Province of Ontario (3.50%, 2043/06/02) was reduced in order to increase the CIBC ETF's yield.

Recent Developments

The level of geopolitical risk disrupted the global economy and financial markets in unprecedented and unpredictable ways. This has resulted in significant volatility and uncertainty in financial markets. It is unclear what further actions may be taken by governments and the resulting impact on global economies, businesses and financial markets. Inflation has increased in many markets across the globe, leading central banks to raise interest rates in order to counter rapidly rising prices. These factors may adversely affect the CIBC ETF's performance. The Manager continues to monitor ongoing developments and the impact to investment strategies.

Related Party Transactions

Canadian Imperial Bank of Commerce (*CIBC*) and its affiliates have the following roles and responsibilities with respect to the CIBC ETF, and receive the fees described below in connection with their roles and responsibilities.

Manager, Trustee, and Portfolio Advisor of the CIBC ETF CAMI, a wholly-owned subsidiary of CIBC, is the CIBC ETF's Manager, Trustee, and Portfolio Advisor. CAMI receives management fees with respect to the CIBC ETF's day-to-day business and operations, calculated based on the net asset value of units of the CIBC ETF as described in Management Fees section. As Trustee, CAMI holds title to the CIBC ETF's property (cash and securities) on behalf of its unitholders. As Portfolio Advisor, CAMI provides, or arranges to provide for, investment advice and portfolio management services to the CIBC ETF. CAMI also compensates dealers in connection with their marketing activities regarding the CIBC ETF. From time to time, CAMI may invest in units of the CIBC ETF.

Designated Broker and Dealer

CAMI has entered into an agreement with CIBC World Markets Inc. (*CIBC WM*), an affiliate of CAMI, to act as designated broker and dealer for distribution of the CIBC ETF, on terms and conditions that are comparable to arm's length agreements in the exchange traded funds industry.

Brokerage Arrangements and Soft Dollars

The Portfolio Advisor makes decisions, including the selection of markets and dealers and the negotiation of commissions, with respect

to the purchase and sale of portfolio securities, certain derivative products and the execution of portfolio transactions. Brokerage business may be allocated by the Portfolio Advisor to CIBC WM and CIBC World Markets Corp., each a subsidiary of CIBC. CIBC WM and CIBC World Markets Corp. may also earn spreads on the sale of fixed income and other securities, and certain derivative products to the CIBC ETF. A spread is the difference between the bid and ask prices for a security in the applicable marketplace, with respect to the execution of portfolio transactions. The spread will differ based upon various factors such as the nature and liquidity of the security.

Dealers, including CIBC WM and CIBC World Markets Corp., may furnish goods and services, other than order execution, to the Portfolio Advisor when they process trades through them (referred to in the industry as "soft-dollar" arrangements). These goods and services are paid for with a portion of the brokerage commissions and assist the Portfolio Advisor with investment decision-making services for the CIBC ETF or relate directly to the execution of portfolio transactions on behalf of the CIBC ETF. Any soft dollar arrangements shall be in compliance with applicable laws.

During the period, the CIBC ETF did not pay any brokerage commissions or other fees to CIBC WM or CIBC World Markets Corp. Spreads associated with fixed income and other securities are not ascertainable and, for that reason, cannot be included when determining these amounts.

CIBC ETF Transactions

The CIBC ETF may enter into one or more of the following transactions (the *Related Party Transactions*) in reliance on the standing instructions issued by the Independent Review Committee (the *IRC*):

- to invest in or hold equity securities of CIBC or issuers related to the Portfolio Advisor;
- to invest in or hold non-exchange-traded debt securities of CIBC or an issuer related to CIBC in a primary offering and in the secondary market;
- to make an investment in the securities of an issuer for which CIBC WM, CIBC World Markets Corp., or any affiliate of CIBC (a "Related Dealer" or the "Related Dealers") acts as an underwriter during the offering of the securities or at any time during the 60-day period following the completion of the offering of such securities, including in respect of equity securities of a reporting issuer pursuant to a "private placement" offering (an offering under exemptions from the prospectus requirements) and for the 60-day period following the completion of the offering, in each case in accordance with certain conditions:
- to purchase equity and debt securities from, or sell them to, a Related Dealer, where it is acting as principal;
- undertake currency and currency derivative transactions where a Related Dealer is the counterparty;
- to purchase securities from, or sell securities to, another investment fund or a managed account managed by the Manager or an affiliate (the inter-fund trades or cross-trades), subject to certain conditions; and
- to engage in in-specie transfers by receiving portfolio securities from, or delivering portfolio securities to, a managed account or another investment fund managed by the Manager or an affiliate in

respect of a purchase or redemption of Units of the CIBC ETF, subject to certain conditions.

At least annually, the IRC reviews the Related Party Transactions for which they have issued standing instructions. The IRC is required to advise the Canadian securities regulatory authorities, after a matter has been referred or reported to the IRC by the Manager, if it determines that an investment decision was not made in accordance with a condition imposed by securities legislation or the IRC in any Related Party Transactions requiring its approval.

Custodian

CIBC Mellon Trust Company is the custodian of the CIBC ETF (the *Custodian*). The Custodian holds cash, securities, and other assets of the CIBC ETF and ensures that those assets are kept separate from any other cash, securities, or other assets that the custodian might be holding. The Custodian also provides other services to the CIBC ETF including record-keeping and processing of foreign exchange transactions. The fees and spreads for the services of the Custodian are paid by the Manager. CIBC owns a 50% interest in the Custodian.

Service Provider

The Custodian also provides certain services to the CIBC ETF, including securities lending, fund accounting and reporting, and portfolio valuation. The Manager receives a fixed administration fee from the Fund, in return, the Manager pays certain operating expenses which includes custodial fees (including all applicable taxes) and the fees for fund accounting, reporting, and fund valuation (including all applicable taxes) to CIBC Mellon Trust Company. Where applicable, securities lending fees are applied against the revenue received by the Fund.

- The trading expense ratio represents total commissions and other portfolio transaction costs before income taxes expressed as an annualized percentage of the daily average net asset value during the period. Spreads associated with fixed income securities trading are not ascertainable and, for that reason, are not included in the trading expense ratio calculation.
- The portfolio turnover rate indicates how actively the portfolio advisor and/or portfolio sub-advisor manages the portfolio investments. A portfolio turnover rate of 100% is equivalent to the CIBC ETF buying and selling all of the securities in its portfolio once in the course of the period. The higher a portfolio turnover rate in a period, the greater the trading costs payable by the CIBC ETF in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of the CIBC ETF.

Management Fees

The CIBC ETF pays CAMI an annual management fee to cover the costs of managing the CIBC ETF. Management fees are based on the CIBC ETF's net asset value and are calculated daily and paid monthly. Management fees are paid to CAMI in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, and office overhead expenses related to the Manager's activities and the fees of the Portfolio Advisor are paid by CAMI out of the management fees received from the CIBC ETFs. The CIBC ETF is required to pay applicable taxes on the management fees paid to CAMI. Refer to the CIBC ETF's prospectus for the annual management fee rate.

For the period ended December 31, 2024, 100% of the management fees collected from the CIBC ETF was attributable to general administration and investment advice.


Past Performance
