Management Discussion of Fund Performance

Investment Objective and Strategies

Investment Objective: CIBC Canadian Resources Fund (referred to as the *Fund*) seeks to provide long-term growth through capital appreciation by investing primarily in a diversified portfolio of securities of Canadian companies involved in or indirectly dependent on the Canadian natural resource industries.

Investment Strategies: The Fund identifies the commodities, securities, and sub-sectors of the resource and resource-related groups that are expected to outperform. Industry fundamentals (commodity supply and demand levels) are assessed to form a view and identify opportunities. Adjustments to the portfolio are based on an assessment of industry and company fundamentals, including analysis of company financial statements, evaluation of assets, future growth prospects, and assessment of management teams.

Risk

The Fund is a natural resources equity fund that is suitable for long term investors who can tolerate high investment risk.

For the period ended December 31, 2023, the Fund's overall level of risk remained as discussed in the simplified prospectus.

Results of Operations

The Fund's portfolio advisor is CIBC Asset Management Inc. (referred to as *CAMI* or the *Portfolio Advisor*). The commentary that follows provides a summary of the results of operations for the period ended December 31, 2023. All dollar figures are expressed in thousands, unless otherwise indicated.

The Fund's net asset value decreased by 12% during the period, from \$27,516 as at December 31, 2022 to \$24,214 as at December 31, 2023. Net redemptions of \$2,814 and negative investment performance resulted in an overall decrease in net asset value.

Class A units of the Fund posted a return of -2.2% for the period. The Fund's primary benchmark, the S&P/TSX Composite Index (referred to as the *primary benchmark*), returned 11.8% for the same period. The Fund's return is after the deduction of fees and expenses, unlike the primary benchmark's return. See the section *Past Performance* for the returns of other classes of units offered by the Fund.

Inflation and inflation expectations remained a concern in 2023, influencing investor expectations for interest rates and their impact on the U.S. dollar. There were also concerns about weak gross domestic product growth or outright recession in key natural resource end-markets. The conflict in Ukraine and related sanctions against Russia continued to influence global commodity markets. Later in the year, the conflict in Gaza affected energy and gold prices.

Underweight exposure to uranium detracted significantly from the Fund's performance. Individual detractors from the Fund's performance included an underweight position in Cameco Corp. and overweight positions in First Quantum Minerals Ltd. and Franco-Nevada Corp.

Cameco executed well operationally and market sentiment toward uranium improved through the year. The stock was a strong outperformer. The Panamanian government ordered First Quantum's cornerstone Cobre Panama mine closed. Franco-Nevada had significant exposure to Cobre Panama and lost value with the closure of the mine and related social unrest.

Conversely, exposure to steel and steel inputs like iron ore and metallurgical coal moderately contributed to the Fund's performance. Individual contributors to the Fund's performance included overweight exposures to Reliance Steel & Aluminum Co., Marathon Petroleum Corp. and Kinross Gold Corp.

Reliance Steel & Aluminum executed well relative to market expectations and Marathon Petroleum consistently beat expectations over the year, with share buybacks adding further support for the stock. Kinross Gold executed well on its 2023 plans and benefited from the rise in the gold price during the year.

During the period, the Portfolio Advisor added new positions in K92 Mining Inc., B2Gold Corp., ERO Copper Corp., Freeport-McMoRan Inc. and Cameco to the Fund.

K92 Mining has impressive recent exploration results, with a promise of meaningful production growth over the medium to longer term. B2Gold has a strong balance sheet and near-term potential from a pending mine feasibility study. The Portfolio Advisor believes the company can easily finance a recently acquired mine and maintain its dividend distribution.

The Portfolio Advisor forecasts ERO Copper is 14-16 months away from turning free cash flow positive. The company may more than double production by 2025, while keeping costs below the industry average. The Portfolio Advisor is looking for more copper exposure and moved from an underweight to an overweight position in Freeport-McMoRan on the recent pullback in copper prices.

The Portfolio Advisor added a position in Cameco, which offers unique exposure to uranium and the nuclear value chain in top tier jurisdictions.

The Portfolio Advisor increased the Fund's exposures to Enbridge Inc. and Gibson Energy Inc. and, ultimately, First Quantum. The Portfolio Advisor added to Enbridge on bought deal financing that was attractive for the Fund and the company. First Quantum was cut to market weight earlier in the year due to the risk around the Cobre Panama mine. The Portfolio Advisor later raised the Fund's exposure again given its potential to outperform on free cash flow generation and deleveraging.

The Portfolio Advisor eliminated positions in SSR Mining Inc., Newmont Corp., Orsted AS and Topaz Energy Corp. The Portfolio Advisor lost confidence in SSR Mining's operational execution. The Portfolio Advisor eliminated a small position in Newmont on expected challenges with a recent acquisition. The Portfolio Advisor reduced and then eliminated a position in Topaz Energy on an unattractive expected return and poor outlook for another dividend increase.

The Portfolio Advisor decreased the Fund's positions in Champion Iron Ltd., Teck Resources Ltd., Tourmaline Oil Corp., Barrick Gold Corp. and Franco-Nevada. After the stock rallied above the Portfolio Advisor's target price, Champion Iron was reduced on an analyst downgrade. It remains a high-quality, cash flow-producing company.

Exposure to Teck Resources was cut due to a Glencore PLC takeover bid and uncertainty around a possible split of the company's coal and copper businesses. The Portfolio Advisor continues to appreciate Tourmaline Oil as a business, but took profit after a stock rally made the valuation multiple too high. The Portfolio Advisor cut back on the Fund's holding in Barrick Gold after underwhelming third-quarter operating results presented risks to 2023 guidance, and reduced the Fund's overweight position in Franco-Nevada given its exposure to the Cobre Panama mine.

Recent Developments

Effective April 27, 2023, Bryan Houston was appointed Chair of the Independent Review Committee.

The COVID-19 pandemic and the Russia-Ukraine war have disrupted the global economy and financial markets in unprecedented and unpredictable ways. This has resulted in significant volatility and uncertainty in financial markets. It is unclear what further actions may be taken by governments and the resulting impact on global economies, businesses and financial markets. Inflation has increased in many markets across the globe, leading central banks to raise interest rates in order to counter rapidly rising prices. These factors may adversely affect the performance of the Fund. The Manager continues to monitor ongoing developments and the impact to investment strategies.

Related Party Transactions

CIBC and its affiliates have the following roles and responsibilities with respect to the Fund, and receive the fees described below in connection with their roles and responsibilities.

Manager

CIBC is the Fund's manager (referred to as the *Manager*). CIBC receives management fees with respect to the Fund's day-to-day business and operations, calculated based on the net asset value of each respective class of units of the Fund as described in the section entitled *Management Fees*. The Manager compensates its wholesalers in connection with their marketing activities regarding the Fund. From time to time, CIBC may invest in units of the Fund.

The Manager pays the Fund's operating expenses (other than certain fund costs) in respect of the class of units of the Fund (except class O unit), which may include but are not limited to, operating and administrative costs; regulatory fees; audit, and legal fees and expenses; trustee, safekeeping, custodial, and any agency fees; and investor servicing costs and costs of unitholder reports, prospectuses, Fund Facts, and other reports, in exchange for the Fund paying a fixed rate administration fee (plus applicable GST/HST) to the Manager with respect to those class of units. For class O units, no fixed administration fee will be charged. The Manager pays the Fund's operating expenses (other than certain Fund costs) allocated to Class O units of the Fund. The fixed administration fee payable by the Fund, may, in any particular period, exceed or be lower than the expenses we incur in providing such services to the Fund.

Trustee

CIBC Trust Corporation, a wholly-owned subsidiary of CIBC, is the Fund's trustee (referred to as the *Trustee*). The Trustee holds title to the Fund's property (cash and securities) on behalf of its unitholders.

Portfolio Advisor

The portfolio advisor provides, or arranges to provide, investment advice and portfolio management services to the Fund. CAMI, a wholly-owned subsidiary of CIBC, is the Fund's portfolio advisor.

Distributor

Dealers and other firms sell the units of the Fund to investors. These dealers and other firms include CIBC's related dealers such as the principal distributor, CIBC Securities Inc. (referred to as *CIBC SI*), the CIBC Investor's Edge discount brokerage division of CIBC Investor Services Inc. (referred to as *CIBC ISI*), the CIBC Imperial Investor Service division of CIBC ISI, and the CIBC Wood Gundy division of CIBC World Markets Inc. (referred to as *CIBC WM*). CIBC SI, CIBC ISI, and CIBC WM are wholly-owned subsidiaries of CIBC.

CIBC may pay trailing commissions to these dealers and firms, in connection with the sale of units of the Fund. These dealers and other firms may pay a portion of these trailing commissions to their advisors who sell units of the Fund to investors.

Brokerage Arrangements and Soft Dollars

The Portfolio Advisor makes decisions, including the selection of markets and dealers and the negotiation of commissions, with respect to the purchase and sale of portfolio securities, certain derivative products and the execution of portfolio transactions. Brokerage

business may be allocated by the Portfolio Advisor to CIBC WM and CIBC World Markets Corp., each a subsidiary of CIBC. CIBC WM and CIBC World Markets Corp. may also earn spreads on the sale of fixed income securities and other securities and certain derivative products to the Fund. A spread is the difference between the bid and ask prices for a security in the applicable marketplace, with respect to the execution of portfolio transactions. The spread will differ based upon various factors such as the type and liquidity of the security.

Dealers, including CIBC WM and CIBC World Markets Corp., may furnish goods and services, other than order execution, to the Portfolio Advisor in partial exchange for processing trades through them (referred to in the industry as "soft dollar" arrangements). These goods and services are paid for with a portion of the brokerage commissions and assist the Portfolio Advisor with investment decision-making services for the Fund or relate directly to the execution of portfolio transactions on behalf of the Fund.

During the period, the Fund paid brokerage commissions and other fees of \$1,024 to CIBC WM and \$66 to CIBC World Markets Corp. Spreads associated with fixed income and other securities are not ascertainable and, for that reason, cannot be included when determining these amounts.

Fund Transactions

The Fund may enter into one or more of the following transactions (referred to as the *Related Party Transactions*) in reliance on the standing instructions issued by the IRC:

- invest in or hold equity securities of CIBC or issuers related to a portfolio sub-advisor;
- invest in or hold non-exchange-traded debt securities of CIBC or an issuer related to CIBC, with terms-to-maturity of 365 days or more, issued in a primary offering and in the secondary market;
- make an investment in the securities of an issuer for which CIBC WM, CIBC World Markets Corp., or any affiliate of CIBC (referred to as a *Related Dealer* or the *Related Dealers*) acts as an underwriter during the offering of the securities or at any time during the 60-day period following the completion of the offering of such securities (in the case of a "private placement" offering, in accordance with the exemptive relief order granted by the Canadian securities regulatory authorities and in accordance with the policies and procedures relating to such investment);
- purchase equity or debt securities from or sell them to a Related Dealer, where it is acting as principal;
- undertake currency and currency derivative transactions where a Related Dealer is the counterparty;
- purchase securities from or sell securities to another investment fund or a managed account managed by the Manager or an affiliate; and
- engage in in-specie transfers by receiving portfolio securities from, or delivering portfolio securities to, a managed account or another investment fund managed by the Manager or an affiliate, in respect of a purchase or redemption of units in the fund, subject to certain conditions.

At least annually, the IRC reviews the Related Party Transactions for which they have issued standing instructions. The IRC is required to advise the Canadian securities regulatory authorities, after a matter has been referred or reported to the IRC by the Manager, if it determines that an investment decision was not made in accordance with a condition imposed by securities legislation or the IRC in any Related Party Transactions requiring its approval.

Custodian

CIBC Mellon Trust Company is the Fund's custodian (referred to as the *Custodian*). The Custodian holds all cash and securities for the Fund and ensures that those assets are kept separate from any other cash or securities that the Custodian might be holding. The Custodian also provides other services to the Fund including record-keeping and processing of foreign exchange transactions. The fees and spreads for the services of the Custodian directly related to the execution of portfolio transactions by the Fund are paid by CAMI and/or the dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month. All other fees and spreads for the services of the Custodian are paid by the Manager and charged to the Fund on a recoverable basis. CIBC owns a 50% interest in the Custodian.

Service Provider

CIBC Mellon Global Securities Services Company Inc. (referred to as *CIBC GSS*) provides certain services to the Fund, including securities lending, fund accounting and reporting, and portfolio valuation. Such servicing fees are paid by the Manager and charged to the Fund on a recoverable basis. CIBC indirectly owns a 50% interest in CIBC GSS.

⁶ The decision to waive management fees is at the discretion of the Manager. The practice of waiving management fees may continue indefinitely or may be terminated at any time without notice to unitholders. The management expense ratio before waivers or absorptions includes the fees attributable to exchange traded funds, where applicable.

⁷ The trading expense ratio represents total commissions and other portfolio transaction costs before income taxes expressed as an annualized percentage of the daily average net asset value during the period. Spreads associated with fixed income securities trading are not ascertainable and, for that reason, are not included in the trading expense ratio calculation.

⁸ The portfolio turnover rate indicates how actively the portfolio advisor and/or portfolio sub-advisor manages the portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a portfolio turnover rate in a period, the greater the trading costs payable by the Fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of the Fund.

Management Fees

The Fund, either directly or indirectly, pays CIBC an annual management fee to cover the costs of managing the Fund. Management fees are based on the Fund's net asset value and are calculated daily and paid monthly. Management fees are paid to CIBC in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, office overhead expenses and trailing commissions are paid by CIBC out of the management fees received from the Fund. The Fund is required to pay applicable taxes on the management fees paid to CIBC. Refer to the Simplified Prospectus for the annual management fee rate for each class of units. For Class O units, the management fee is negotiated with and paid by, or as directed by, unitholders or dealers and discretionary managers on behalf of unitholders. Such Class O management fee will not exceed the Class F unit management fee rate.

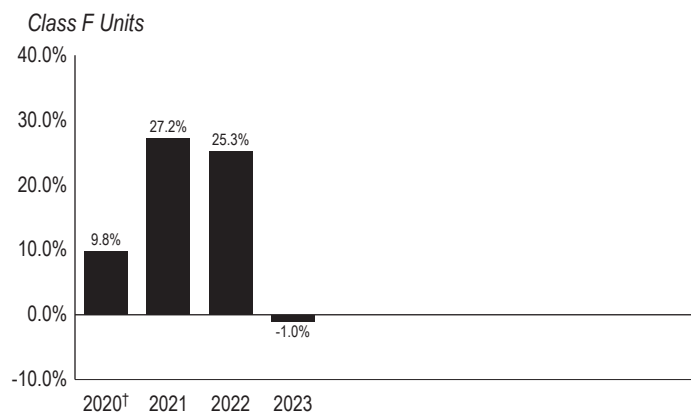
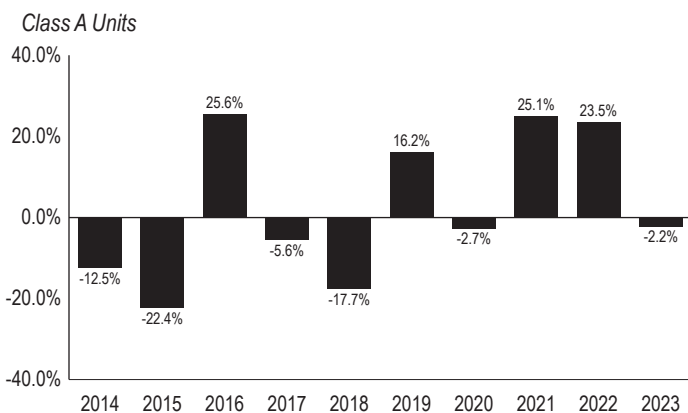
Past Performance

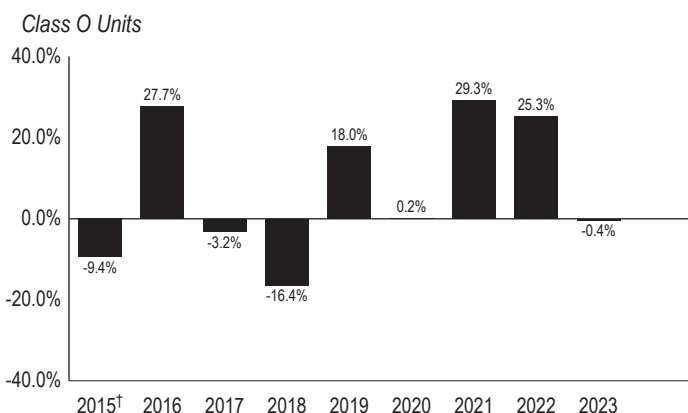

S&P/TSX Energy GICS Level 1 Index is a float-adjusted market capitalization weighted index. The constituents of the Index are a subset of the constituents of the S&P/TSX Composite Index that have been classified as part of the energy sector according to the Global Industry Classification Standard.
