Management Discussion of Fund Performance

Investment Objective and Strategies

Investment Objective: CIBC Dividend Growth Fund (the *Fund*) seeks to maximize income and potential capital growth by investing primarily in Canadian equity securities that produce dividend income.

Investment Strategies: The Fund identifies stocks that have attractive dividend yields and capital appreciation potential. The Fund aims to add value through prudent security selection based on fundamental, bottom-up analysis and through the allocation of assets between common and preferred shares, bonds, and other securities based on a review of economic and capital market conditions.

Risk

The Fund is a Canadian dividend and income equity fund that is suitable for medium to long term investors who can tolerate medium investment risk.

For the period ended December 31, 2024, the Fund's overall level of risk remained as discussed in the simplified prospectus.

Results of Operations

The Fund's portfolio advisor is CIBC Asset Management Inc. (*CAMI* or the *Portfolio Advisor*). The commentary that follows provides a summary of the results of operations for the period ended December 31, 2024. All dollar figures are expressed in thousands, unless otherwise indicated.

The Fund's net asset value increased by 13% during the period, from \$753,375 as at December 31, 2023 to \$850,481 as at December 31, 2024. Positive investment performance was partially offset by net redemptions of \$49,630, resulting in an overall increase in net asset value.

Class A units of the Fund posted a return of 20.3% for the period. The Fund's benchmark, the S&P/TSX Composite Dividend Index (the benchmark), returned 19.8% for the same period. The Fund's return is after the deduction of fees and expenses, unlike the benchmark's return. See the section *Past Performance* for the returns of other classes of units offered by the Fund.

During the period, investors were concerned about the prospects of continued high inflation, geopolitical tensions and the start of interest-rate cuts in Canada. However, equity markets delivered a second year of double-digit returns. In Canada, employment growth moderated, business productivity lagged and overall economic growth stalled. This led to the Bank of Canada (the *BoC*) lowering its policy interest rate ahead of the U.S. Federal Reserve Board (the *Fed*).

At the start of 2024, futures markets had anticipated five or six interestrate cuts by both the Fed and the BoC for the year. However, these expectations changed in response to persistent inflation. The Fed lowered its federal funds rate three times in the second half of the year, ending the period at 4.25%–4.50%. The BoC cut its overnight rate five times, for a cumulative easing of 1.75%, reflective of a relatively weaker economy compared to the U.S.

Energy prices fluctuated within a range of \$65–\$90 USD throughout the year. However, energy prices ended the year toward the lower end of the range given concerns of falling demand, increased supply and uncertainty around the Organization of the Petroleum Exporting Countries' policy. Mega-capitalization information technology stocks showed strength, as just six of these companies exceeded \$1 trillion USD in market capitalization.

Overweight allocations to the health care and financials sectors contributed to the Fund's performance. Stock selection within the industrials, financials and communication services sectors also contributed to performance. Overweight exposure to select insurance companies contributed to performance, as did off-benchmark holdings in small- and mid-cap stocks.

Overweight holdings in Fairfax Financial Holdings Ltd., Manulife Financial Corp. and Element Fleet Management Corp. were the largest individual contributors to the Fund's performance. Despite a negative short report, earnings growth at Fairfax Financial Holdings boosted its share price performance.

Manulife Financial benefitted from the sale of less-desirable segments of its variable annuity and long-term care book, leaving the more attractive insurance and asset management business intact. Element Fleet Management benefitted from consistent growth in revenue and

earnings per share. The company continued to gain market share and grow services per employee to improve these metrics.

Stock selection in the consumer discretionary sector detracted from the Fund's performance as investors shifted to the relative safety of certain large-cap defensive stocks. Overweight exposure to communication services detracted from performance amid higher-than-expected competitive intensity, which negatively affected growth.

Underweight holdings in Waste Connections Inc., Dollarama Inc. and TC Energy Corp. detracted from performance. Both Waste Connections and Dollarama performed well despite having sub-par growth. TC Energy's stock performed well after the company successfully spun off its liquids pipeline business.

After exiting a holding in Franco-Nevada Corp., the Portfolio Advisor added a new holding in Osisko Gold Royalties Ltd. to maintain the Fund's gold exposure. Osisko Gold Royalties recently changed direction to become a pure-play, gold-focused royalty and streaming company. It trades at a discount relative to many peers. A new holding in RB Global Inc. was added to the Fund based on improved results at IAA Inc., one of the company's marketplace brands.

Brookfield Renewables Corp. and Brookfield Infrastructure Partners L.P. were increased for their higher dividend yields and on the expectation that interest rates will continue to normalize. A holding in The Toronto Dominion Bank was increased on the announcement of a new CEO.

Franco-Nevada Corp. was sold in favour of the new holding in Osisko Gold Royalties. Magna International Inc. was eliminated because of its disappointing growth outlook. A holding in Algonquin Power & Utilities Corp., which was left over from a previously owned convertible debenture, was also eliminated.

Brookfield Asset Management Inc. was trimmed to shift weight into Brookfield Renewables and Brookfield Infrastructure Partners. The Portfolio Advisor shifted weight from real estate into insurance by initiating a holding in Sun Life Financial Inc. The Portfolio Advisor believes this complements the Fund's overweight allocations to Manulife Financial, as well as to property and casualty and specialty insurance. Nutrien Ltd. was trimmed to reflect the Portfolio Advisor's lower conviction in the holding and in response to increased volatility.

Recent Developments

The level of geopolitical risk disrupted the global economy and financial markets in unprecedented and unpredictable ways. This has resulted in significant volatility and uncertainty in financial markets. It is unclear what further actions may be taken by governments and the resulting impact on global economies, businesses and financial markets. Inflation has increased in many markets across the globe, leading central banks to raise interest rates in order to counter rapidly rising prices. These factors may adversely affect the Fund's performance. The Manager continues to monitor ongoing developments and the impact to investment strategies.

Related Party Transactions

CIBC and its affiliates have the following roles and responsibilities with respect to the Fund, and receive the fees described below in connection with their roles and responsibilities.

Manager

CIBC is the Fund's manager (the *Manager*). CIBC receives management fees with respect to the Fund's day-to-day business and operations, calculated based on the net asset value of each respective class of units of the Fund as described in *Management Fees* section. From time to time, CIBC may invest in units of the Fund.

The Manager pays the Fund's operating expenses (other than certain fund costs) in respect of the class of units of the Fund (except class O unit), which may include but are not limited to, operating and administrative costs; regulatory fees; audit, and legal fees and expenses; trustee, safekeeping, custodial, and any agency fees; and investor servicing costs and costs of unitholder reports, prospectuses, Fund Facts, and other reports, in exchange for the Fund paying a fixed rate administration fee (plus applicable GST/HST) to the Manager with respect to those class of units. For class O units, no fixed administration fee will be charged. The Manager pays the Fund's operating expenses (other than certain Fund costs) allocated to Class O units of the Fund. The fixed administration fee payable by the Fund, may, in any particular period, exceed or be lower than the expenses we incur in providing such services to the Fund.

Trustee

CIBC Trust Corporation (*CIBC Trust*), a wholly-owned subsidiary of CIBC, is the Fund's trustee (the *Trustee*). The Trustee holds title to the Fund's property (cash and securities) on behalf of its unitholders.

Portfolio Advisor

The portfolio advisor provides, or arranges to provide, investment advice and portfolio management services to the Fund. CAMI, a wholly-owned subsidiary of CIBC, is the Fund's portfolio advisor.

Distributor

Dealers and other firms sell the units of the Fund to investors. These dealers and other firms include CIBC's related dealers such as the principal distributor, CIBC Securities Inc. (CIBC SI), the CIBC Investor's Edge discount brokerage division of CIBC Investor Services Inc. (CIBC ISI), the CIBC Imperial Investor Service division of CIBC ISI, and the CIBC Wood Gundy division of CIBC World Markets Inc. (CIBC WM). CIBC SI, CIBC ISI, and CIBC WM are wholly-owned subsidiaries of CIBC.

CIBC may pay trailing commissions to these dealers and firms, in connection with the sale of units of the Fund. These dealers and other firms may pay a portion of these trailing commissions to their advisors who sell units of the Fund to investors.

Brokerage Arrangements and Soft Dollars

The Portfolio Advisor makes decisions, including the selection of markets and dealers and the negotiation of commissions, with respect to the purchase and sale of portfolio securities, certain derivative products and the execution of portfolio transactions. Brokerage business may be allocated by the Portfolio Advisor to CIBC WM and CIBC World Markets Corp., each a subsidiary of CIBC. CIBC WM and CIBC World Markets Corp. may also earn spreads on the sale of fixed income securities and other securities and certain derivative products to the Fund. A spread is the difference between the bid and ask prices for a security in the applicable marketplace, with respect to the execution of

portfolio transactions. The spread will differ based upon various factors such as the type and liquidity of the security.

Dealers, including CIBC WM and CIBC World Markets Corp., may furnish goods and services, other than order execution, to the Portfolio Advisor in partial exchange for processing trades through them (referred to in the industry as "soft dollar" arrangements). These goods and services are paid for with a portion of the brokerage commissions and assist the Portfolio Advisor with investment decision-making services for the Fund or relate directly to the execution of portfolio transactions on behalf of the Fund.

During the period, the Fund paid brokerage commissions and other fees of \$60,219 to CIBC WM; the Fund did not pay any brokerage commissions or other fees to CIBC World Markets Corp. Spreads associated with fixed income and other securities are not ascertainable and, for that reason, cannot be included when determining these amounts.

Fund Transactions

The Fund may enter into one or more of the following transactions (*Related Party Transactions*) in reliance on the standing instructions issued by the IRC:

- invest in or hold equity securities of CIBC or issuers related to a portfolio sub-advisor;
- invest in or hold non-exchange-traded debt securities of CIBC or an issuer related to CIBC, with terms-to-maturity of 365 days or more, issued in a primary offering and in the secondary market;
- make an investment in the securities of an issuer for which CIBC WM, CIBC World Markets Corp., or any affiliate of CIBC (the Related Dealer or Related Dealers) acts as an underwriter during the offering of the securities or at any time during the 60-day period following the completion of the offering of such securities (in the case of a "private placement" offering, in accordance with the exemptive relief order granted by the Canadian securities regulatory authorities and in accordance with the policies and procedures relating to such investment);
- purchase equity or debt securities from or sell them to a Related Dealer, where it is acting as principal;
- undertake currency and currency derivative transactions where a Related Dealer is the counterparty;
- purchase securities from or sell securities to another investment fund or a managed account managed by the Manager or an affiliate;
- engage in in-specie transfers by receiving portfolio securities from, or delivering portfolio securities to, a managed account or another investment fund managed by the Manager or an affiliate, in respect of a purchase or redemption of units in the fund, subject to certain conditions.

At least annually, the IRC reviews the Related Party Transactions for which they have issued standing instructions. The IRC is required to advise the Canadian securities regulatory authorities, after a matter has been referred or reported to the IRC by the Manager, if it determines that an investment decision was not made in accordance with a

condition imposed by securities legislation or the IRC in any Related Party Transactions requiring its approval.

Custodian

CIBC Mellon Trust Company is the Fund's custodian (the *Custodian*). The Custodian holds all cash and securities for the Fund and ensures that those assets are kept separate from any other cash or securities that the Custodian might be holding. The Custodian also provides other services to the Fund including record-keeping and processing of foreign exchange transactions. The fees and spreads for the services of the Custodian directly related to the execution of portfolio transactions by the Fund are paid by CAMI and/or the dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month. All other fees and spreads for the services of the Custodian are paid by the Manager, in return for receiving a fixed administration fee from the Fund. CIBC owns a 50% interest in the Custodian.

Service Provider

The Custodian also provides certain services to the Fund, including securities lending, fund accounting and reporting, and portfolio valuation. The Manager receives a fixed administration fee from the Fund, in return, the Manager pays certain operating expenses which includes custodial fees (including all applicable taxes) and the fees for fund accounting, reporting, and fund valuation (including all applicable taxes) to CIBC Mellon Trust Company. Where applicable, securities lending fees are applied against the revenue received by the Fund.

The management expense ratio before waivers or absorptions includes the fees attributable to exchange traded funds, where applicable.
- 7 The trading expense ratio represents total commissions and other portfolio transaction costs before income taxes expressed as an annualized percentage of the daily average net asset value during the period. Spreads associated with fixed income securities trading are not ascertainable and, for that reason, are not included in the trading expense ratio calculation.
- The portfolio turnover rate indicates how actively the portfolio advisor and/or portfolio sub-advisor manages the portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a portfolio turnover rate in a period, the greater the trading costs payable by the Fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of the Fund.

Management Fees

The Fund, either directly or indirectly, pays CIBC an annual management fee to cover the costs of managing the Fund. Management fees are based on the Fund's net asset value and are calculated daily and paid monthly. Management fees are paid to CIBC in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, office overhead expenses and trailing commissions are paid by CIBC out of the management fees received from the Fund. The Fund is required to pay applicable taxes on the management fees paid to CIBC. Refer to the Simplified Prospectus for the annual management fee rate for each class of units. For Class O units, the management fee is negotiated with and paid by, or as directed by, unitholders or dealers and discretionary managers on behalf of unitholders. Such Class O management fee will not exceed the Class F unit management fee rate.

The following table shows a breakdown of the services received in consideration of the management fees, as a percentage of the management fees collected from the Fund for the period ended December 31, 2024. These amounts do not include waived fees or absorbed expenses.


Past Performance




Year-by-Year Returns
