



## Annual Management Report of Fund Performance

### Management Discussion of Fund Performance

#### Investment Objective and Strategies

Investment Objective: CIBC European Equity Fund (referred to as the *Fund*) seeks to provide long-term growth through capital appreciation by investing primarily in equity securities of medium to large companies, located in select member countries of the European Union, as well as securities of companies in other European countries with established stock exchanges, and in less developed European countries.

Investment Strategies: The Fund focuses on industries that have generated consistent and predictable, above-average earnings by investing in securities such as common shares, preferred shares, convertible bonds, and warrants.

#### Risk

The Fund is a European equity fund that is suitable for long-term investors who can tolerate medium investment risk.

For the period ended December 31, 2020, the Fund's overall level of risk remained as discussed in the simplified prospectus.

#### Results of Operations

The Fund's portfolio advisor is CIBC Asset Management Inc. (referred to as *CAMI* or the *Portfolio Advisor*). The commentary that follows provides a summary of the results of operations for the period ended December 31, 2020. All dollar figures are expressed in thousands, unless otherwise indicated.

The Fund's net asset value increased by 6% during the period, from \$343,697 as at December 31, 2019 to \$363,771 as at December 31, 2020. Positive investment performance was partially offset by net redemptions of \$22,582, resulting in an overall increase in net asset value.

Class A units of the Fund posted a return of 10.3% for the period. The Fund's benchmark, the MSCI Europe Index (referred to as the *benchmark*), returned 4.1% for the same period. The Fund's return is after the deduction of fees and expenses, unlike the benchmark's return. See the section *Past Performance* for the returns of other classes of units offered by the Fund.

Although the global economy and financial markets began 2020 relatively strong, measures to contain the spread of COVID-19 hindered economies around the world. In response, central banks and governments implemented massive monetary and fiscal stimulus programs, including substantial asset purchases, to support their respective economies and financial markets. Equity prices fell sharply in March before rallying in response to these unprecedented stimulus programs, which kept global yields at historically low levels.

Investor optimism in the second half of 2020 bolstered equity prices, as well as a recovery in commodity prices. Despite continued high COVID-19 infection rates, this optimism was fuelled by hopes of economic re-openings and progress toward the widespread distribution of effective COVID-19 vaccines. Other forces driving stronger equity prices included the resolution of the U.S. election, expectations of a deal between the United Kingdom and European Union, and a limit on oil output by the Organization of the Petroleum Exporting Countries (referred to as *OPEC*).

Despite some continued signs of recovery, with countries like Germany and others reporting positive manufacturing data, increasing restrictions and renewed lockdown measures in response to the pandemic's second wave created some heightened uncertainty near the end of the period.

The Fund's holdings in defensive, high-quality companies contributed to performance earlier in the period, when there was significant equity market volatility in response to the pandemic. As optimism regarding vaccines drove investors into more cyclical stocks (those that tend to be more sensitive to an economic recovery) in November, these holdings generally underperformed. The Fund's stock selection in the energy and financials sectors also contributed to performance, as did a slight underweight position in the energy sector.

Individual contributors to performance included holdings in Tomra Systems ASA, Neste Oil OYJ and Orsted AS. Finnish refiner Neste experienced strong demand, while the company expanded its margins through improved sourcing of raw materials. Danish offshore wind farm operator Orsted benefited from progress on climate change, renewables and energy usage, especially in Europe. Norway-based

Tomra Systems benefited from continued gains in recycling infrastructure globally.

A moderate underweight exposure to – and stock selection in – the materials sector detracted from the Fund's performance. Individual detractors from performance included WH Smith PLC, Airbus SE and Safran SA. WH Smith weakened as travel restrictions reduced the company's revenue and margins from its retail locations at train stations, bus stations and airports. Aerospace companies Airbus and Safran struggled in response to low order numbers and uncertainty about the resumption of air travel.

The Portfolio Advisor added several new holdings to the Fund during the period. The Portfolio Advisor believed Heineken NV and Ashted Group PLC had reached attractive valuation levels on stock price weakness. The Portfolio Advisor believed Lonza Group AG should benefit from research and other efforts toward containing and treating COVID-19. Umicore SA is a key supplier of batteries for electric cars, and the Portfolio Advisor expects the company to benefit as these vehicles increase in popularity. The Portfolio Advisor believes Dassault Systèmes SA and Aon PLC offer strong fundamentals.

Several of the Fund's existing holdings were increased during the period. The Portfolio Advisor believed that both KBC Group NV and Mowi ASA offered attractive valuations, and the Portfolio Advisor believed Mowi should also benefit from increasing global demand for salmon.

The Portfolio Advisor eliminated several of the Fund's holdings during the period. The Portfolio Advisor believed weakening travel and retail trends could have a negative impact on retailers Prada S.p.A. and Associated British Foods PLC. FinecoBank Banca Fineco SPA was eliminated in response to the slowing Italian economy. DiaSorin SPA and Straumann Holding AG were sold based on valuation. The Portfolio Advisor sold Safran and Airbus to reduce the Fund's exposure to the aerospace industry.

The Fund's holdings in The Thule Group AB and Neste were reduced to take profits after a period of gains.

#### **Recent Developments**

On July 6, 2020, Class F units of the Fund were made available for purchase.

The composition of the Independent Review Committee (referred to as *IRC*) changed. Don Hunter and Merle Kriss retired effective April 26, 2020. Effective April 27, 2020, David Forster and Deborah Leckman were appointed as members of the IRC. Marcia Lewis Brown was appointed Chair effective April 1, 2020.

The international spread of COVID-19 caused a significant slowdown in the global economy and volatility in financial markets. The COVID-19 outbreak may adversely affect global markets and the Fund's performance.

#### **Related Party Transactions**

Canadian Imperial Bank of Commerce (referred to as *CIBC*) and its affiliates have the following roles and responsibilities with respect to the Fund, and receive the fees described below in connection with their roles and responsibilities.

#### *Manager*

CIBC is the Fund's manager (referred to as the *Manager*). CIBC receives management fees with respect to the Fund's day-to-day business and operations, calculated based on the net asset value of each respective class of units of the Fund as described in the section entitled *Management Fees*. The Manager compensates its wholesalers in connection with their marketing activities regarding the Fund. From time to time, CIBC may invest in units of the Fund.

#### *Trustee*

CIBC Trust Corporation, a wholly-owned subsidiary of CIBC, is the Fund's trustee (referred to as the *Trustee*). The Trustee holds title to the Fund's property (cash and securities) on behalf of its unitholders.

#### *Portfolio Advisor*

The portfolio advisor provides, or arranges to provide, investment advice and portfolio management services to the Fund. CAMI, a wholly-owned subsidiary of CIBC, is the Fund's portfolio advisor.

#### *Distributor*

Dealers and other firms sell the units of the Fund to investors. These dealers and other firms include CIBC's related dealers such as the principal distributor, CIBC Securities Inc. (referred to as *CIBC SI*), the CIBC Investor's Edge discount brokerage division of CIBC Investor Services Inc. (referred to as *CIBC ISI*), the CIBC Imperial Investor Service division of CIBC ISI, and the CIBC Wood Gundy division of CIBC World Markets Inc. (referred to as *CIBC WM*). CIBC SI, CIBC ISI, and CIBC WM are wholly-owned subsidiaries of CIBC.

CIBC may pay trailing commissions to these dealers and firms, except for CIBC SI, in connection with the sale of units of the Fund. These dealers and other firms may pay a portion of these trailing commissions to their advisors who sell units of the Fund to investors. CIBC does not pay trailing commissions to CIBC SI for selling units of the Fund, although overall sales of CIBC funds may be considered in assessing the performance of their advisors and may therefore contribute to their annual compensation.

#### *Brokerage Arrangements and Soft Dollars*

The Portfolio Advisor makes decisions, including the selection of markets and dealers and the negotiation of commissions, with respect to the purchase and sale of portfolio securities, certain derivative products and the execution of portfolio transactions. Brokerage business may be allocated by the Portfolio Advisor to CIBC WM and CIBC World Markets Corp., each a subsidiary of CIBC. CIBC WM and CIBC World Markets Corp. may also earn spreads on the sale of fixed income securities and other securities and certain derivative products to the Fund. A spread is the difference between the bid and ask prices for a security in the applicable marketplace, with respect to the execution of portfolio transactions. The spread will differ based upon various factors such as the type and liquidity of the security.

Dealers, including CIBC WM and CIBC World Markets Corp., may furnish goods and services, other than order execution, to the Portfolio Advisor in partial exchange for processing trades through them (referred to in the industry as "soft dollar" arrangements). These goods and services are paid for with a portion of the brokerage commissions

and assist the Portfolio Advisor with investment decision-making services for the Fund or relate directly to the execution of portfolio transactions on behalf of the Fund.

In addition, CIBC may enter into commission recapture arrangements with certain dealers with respect to the Fund. Any commission recaptured will be paid to the Fund.

During the period, the Fund paid brokerage commissions and other fees of \$24,120 to CIBC WM; the Fund did not pay any brokerage commissions or other fees to CIBC World Markets Corp. Spreads associated with fixed income and other securities are not ascertainable and, for that reason, cannot be included when determining these amounts.

#### *Fund Transactions*

The Fund may enter into one or more of the following transactions (referred to as the *Related Party Transactions*) in reliance on the standing instructions issued by the IRC:

- invest in or hold equity securities of CIBC or issuers related to a portfolio sub-advisor;
- invest in or hold non-exchange-traded debt securities of CIBC or an issuer related to CIBC, with terms-to-maturity of 365 days or more, issued in a primary offering and in the secondary market;
- make an investment in the securities of an issuer for which CIBC WM, CIBC World Markets Corp., or any affiliate of CIBC (referred to as a *Related Dealer*) acts as an underwriter during the offering of the securities or at any time during the 60-day period following the completion of the offering of such securities (in the case of a "private placement" offering, in accordance with the exemptive relief order granted by the Canadian securities regulatory authorities and in accordance with the policies and procedures relating to such investment);
- purchase equity or debt securities from or sell them to a Related Dealer, where it is acting as principal;
- undertake currency and currency derivative transactions where a Related Dealer is the counterparty;
- purchase securities from or sell securities to another investment fund or a managed account managed by the Manager or an affiliate; and
- engage in in-specie transfers by receiving portfolio securities from, or delivering portfolio securities to, a managed account or another investment fund managed by the Manager or an affiliate, in respect of a purchase or redemption on units in the fund, subject to certain conditions.

At least annually, the IRC reviews the Related Party Transactions for which they have issued standing instructions. The IRC is required to advise the Canadian securities regulatory authorities, after a matter has been referred or reported to the IRC by the Manager, if it determines that an investment decision was not made in accordance with a condition imposed by securities legislation or the IRC in any Related Party Transactions requiring its approval.

#### *Custodian*

CIBC Mellon Trust Company is the Fund's custodian (referred to as the *Custodian*). The Custodian holds all cash and securities for the Fund and ensures that those assets are kept separate from any other cash or securities that the Custodian might be holding. The Custodian also provides other services to the Fund including record-keeping and processing of foreign exchange transactions. The Custodian may hire sub-custodians for the Fund. The fees and spreads for services of the Custodian directly related to the execution of portfolio transactions by the Fund are paid by CAMI and/or dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month. All other fees and spreads for the services of the Custodian are paid by the Manager and charged to the Fund on a recoverable basis. CIBC owns a 50% interest in the Custodian.

#### *Service Provider*

CIBC Mellon Global Securities Services Company (referred to as *CIBC GSS*) provides certain services to the Fund, including securities lending, fund accounting and reporting, and portfolio valuation. Such servicing fees are paid by the Manager and charged to the Fund on a recoverable basis. CIBC indirectly owns a 50% interest in CIBC GSS.

## Management Fees

The Fund, either directly or indirectly, pays CIBC an annual management fee to cover the costs of managing the Fund. Management fees are based on the Fund's net asset value and are calculated daily and paid monthly. Management fees are paid to CIBC in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, office overhead expenses and trailing commissions are paid by CIBC out of the management fees received from the Fund. The Fund is required to pay applicable taxes on the management fees paid to CIBC. Refer to the Simplified Prospectus for the annual management fee rate for each class of units. For Class O units, the management fee is negotiated with and paid by, or as directed by, unitholders or dealers and discretionary managers on behalf of unitholders. Such Class O management fee will not exceed the Class F unit management fee rate.

The following table shows a breakdown of the services received in consideration of the management fees, as a percentage of the management fees collected from the Fund for the period ended December 31, 2020. These amounts do not include waived fees or absorbed expenses.

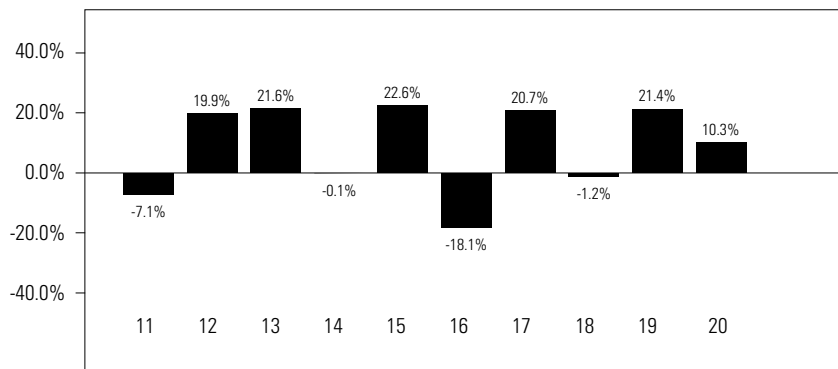

Class A Units

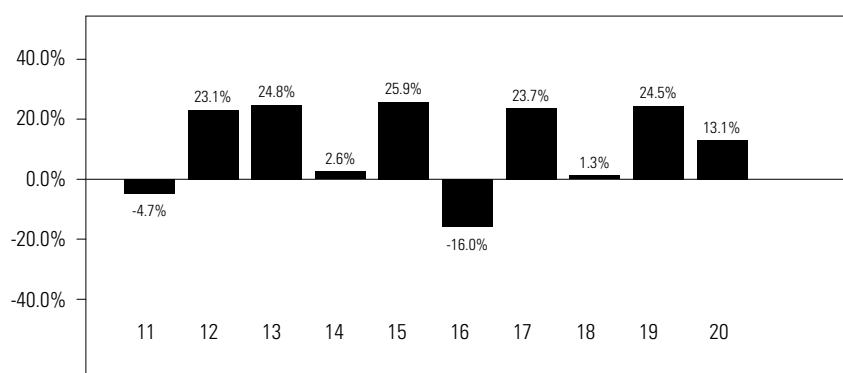


Class F Units
