Management Discussion of Fund Performance

Investment Objective and Strategies

Investment Objective: CIBC Global Equity Fund (referred to as the *Fund*) seeks to provide long-term growth through capital appreciation by investing primarily in a diversified portfolio of equity securities of foreign companies located in North America, Europe, the Far East, and the Pacific Basin.

Investment Strategies: The Fund invests in equity securities of companies located around the world that are priced below their intrinsic value as determined by the portfolio advisor. Investments will be focused in areas the portfolio advisor finds the most compelling at any given time. The Fund also attempts to hold a portfolio that is diversified among different sectors and geographies using multiple risk factors in relation to perceived valuation attractiveness.

Risk

The Fund is a global equity fund that is suitable for long-term investors who can tolerate medium investment risk.

For the period ended December 31, 2020, the Fund's overall level of risk remained as discussed in the simplified prospectus.

Results of Operations

The Fund's portfolio advisor is CIBC Asset Management Inc. (referred to as *CAMI* or the *Portfolio Advisor*). The commentary that follows provides a summary of the results of operations for the period ended December 31, 2020. All dollar figures are expressed in thousands, unless otherwise indicated.

The Fund's net asset value increased by 1% during the period, from \$53,398 as at December 31, 2019 to \$53,908 as at December 31, 2020. Positive investment performance was partially offset by net redemptions of \$3,874, resulting in an overall increase in net asset value.

Class A units of the Fund posted a return of 8.9% for the period. The Fund's benchmark, the MSCI World Index (referred to as the *benchmark*), returned 14.5% for the same period. The Fund's return is after the deduction of fees and expenses, unlike the benchmark's

return. See the section *Past Performance* for the returns of other classes of units offered by the Fund.

Although the global economy and financial markets began 2020 relatively strong, measures to contain the spread of COVID-19 hindered economies around the world. In response, central banks and governments implemented massive monetary and fiscal stimulus programs, including substantial asset purchases, to support their respective economies and financial markets.

The spring economic slowdown reduced demand for commodities, which, in combination with oversupply, led to a brief period of negative crude oil prices. Equity prices fell sharply in March before rallying in response to the unprecedented stimulus programs, which kept global yields at historically low levels. The price of gold reached record highs.

Investor optimism in the second half of 2020 supported equity prices, as well as a recovery in commodity prices. Despite high COVID-19 infection rates, this optimism was fuelled by hopes of economic re-openings and progress toward the widespread distribution of effective COVID-19 vaccines. Other forces driving stronger equity prices included the resolution of the U.S. election, expectations of a deal between the U.K. and European Union, and a limit on oil output by the Organization of the Petroleum Exporting Countries (referred to as *OPEC*).

U.S. equity markets ended the period substantially higher and reached all-time highs during the period. International developed markets advanced, but lagged the performance of emerging markets equities. Information technology stocks benefited substantially as lockdowns and physical distancing prompted work, shopping and socializing to increasingly move online. The travel, aerospace and leisure industries, on the other hand, were severely disrupted by the pandemic.

In the period from January 1 to June 25, 2020, exposure to emerging markets currencies detracted from the Fund's performance, as investors pulled out of these more volatile markets in response to the pandemic. A significant underweight allocation to U.S. equities also detracted from performance as U.S. markets outperformed.

In the period from June 25 to December 31, 2020, an underweight exposure to some outperforming large-capitalization stocks, including Apple Inc., detracted from performance. As optimism regarding the rollout of COVID-19 vaccines resulted in a move into more cyclical stocks in November, the Fund's defensive holdings lagged. Individual detractors from performance included American Tower Corp. and The Home Depot Inc. The Portfolio Advisor added to both these holdings on share price weakness.

A moderate overweight allocation to equities in China, Taiwan and Korea contributed to the Fund's performance in the period ended June 25, as many Asian countries managed the COVID-19 crisis more effectively than a number of other countries and were widely expected to reopen their economies faster.

In the period from June 25 to December 31, the Fund's relatively heavy weighting in high-quality companies and underweight exposure to stocks that are more sensitive to falling interest rates contributed to performance. The Fund's weighting in more cyclical sectors also contributed to performance. Individual contributors to performance included holdings in Taiwan Semiconductor Manufacturing Co. Ltd., Neste OYJ and Orsted AS. Taiwan Semiconductor continued to show strong technological leadership. Finnish refiner Neste experienced strong demand, while the company expanded its margins through improved sourcing of raw materials. Danish offshore wind farm operator Orsted benefited from progress on climate change, renewables and energy usage, especially in Europe.

The Portfolio Advisor added several new holdings in the period after June 25. Suzuki Motor Corp. has what the Portfolio Advisor believes is an attractive valuation, and provides the Fund with additional exposure to India. Linde PLC was also added because it is a high-quality, cyclical stock. The Portfolio Advisor believed Activision Blizzard Inc. had strong fundamentals going into 2021. After positive vaccine news, the Portfolio Advisor added exposure to global travel and leisure through a position in Southwest Airlines Inc. LPL Financial Holdings Inc., a strong wealth management franchise, was added to increase the Fund's exposure to interest rates based on the Portfolio Advisor's view that interest rates would not fall further in 2020.

The Fund's holdings in McDonald's Corp., LVMH Moët Hennessy-Louis Vuitton SA and Novo Nordisk AS were eliminated as these companies reached or exceeded the Portfolio Advisor's estimate of their fair value. The Fund's position in Verisk Analytics Inc. was sold in favour of TransUnion, while Verizon Communications Inc. was sold in favour of Activision Blizzard and Ross Stores Inc. was sold in favour of an increased position in Home Depot.

The Fund's holdings in Cintas Corp. and Taiwan Semiconductor were reduced in response to their significant valuation gains during the period.

The Fund's higher portfolio turnover rate during the period was due to market volatility which created buy and sell opportunities.

Recent Developments

On July 6, 2020, Class F units of the Fund were made available for purchase.

The composition of the Independent Review Committee (referred to as *IRC*) changed. Don Hunter and Merle Kriss retired effective April 26, 2020. Effective April 27, 2020, David Forster and Deborah Leckman were appointed as members of the IRC. Marcia Lewis Brown was appointed Chair effective April 1, 2020.

The international spread of COVID-19 caused a significant slowdown in the global economy and volatility in financial markets. The COVID-19 outbreak may adversely affect global markets and the Fund's performance.

Related Party Transactions

Canadian Imperial Bank of Commerce (referred to as *CIBC*) and its affiliates have the following roles and responsibilities with respect to the Fund, and receive the fees described below in connection with their roles and responsibilities.

Manager

CIBC is the Fund's manager (referred to as the *Manager*). CIBC receives management fees with respect to the Fund's day-to-day business and operations, calculated based on the net asset value of each respective class of units of the Fund as described in the section entitled *Management Fees*. The Manager compensates its wholesalers in connection with their marketing activities regarding the Fund. From time to time, CIBC may invest in units of the Fund.

Trustee

CIBC Trust Corporation, a wholly-owned subsidiary of CIBC, is the Fund's trustee (referred to as the *Trustee*). The Trustee holds title to the Fund's property (cash and securities) on behalf of its unitholders.

Portfolio Advisor

The portfolio advisor provides, or arranges to provide, investment advice and portfolio management services to the Fund. CAMI, a wholly-owned subsidiary of CIBC, is the Fund's portfolio advisor.

Distributor

Dealers and other firms sell the units of the Fund to investors. These dealers and other firms include CIBC's related dealers such as the principal distributor, CIBC Securities Inc. (referred to as *CIBC SI*), the CIBC Investor's Edge discount brokerage division of CIBC Investor Services Inc. (*CIBC ISI*), the CIBC Imperial Investor Service division of CIBC ISI, and the CIBC Wood Gundy division of CIBC World Markets Inc. (referred to as *CIBC WM*). CIBC SI, CIBC ISI, and CIBC WM are wholly-owned subsidiaries of CIBC. CIBC may pay trailing commissions to these dealers and firms, except for CIBC SI, in connection with the sale of units of the Fund. These dealers and other firms may pay a portion of these trailing commissions to their advisors who sell units of the Fund to investors. CIBC does not pay trailing commissions to CIBC SI for selling units of the Fund, although overall sales of CIBC funds may be considered in assessing the performance of their advisors and may therefore contribute to their annual compensation.

Brokerage Arrangements and Soft Dollars

The Portfolio Advisor makes decisions, including the selection of markets and dealers and the negotiation of commissions, with respect

to the purchase and sale of portfolio securities, certain derivative products and the execution of portfolio transactions. Brokerage business may be allocated by the Portfolio Advisor to CIBC WM and CIBC World Markets Corp., each a subsidiary of CIBC. CIBC WM and CIBC World Markets Corp. may also earn spreads on the sale of fixed income securities and other securities and certain derivative products to the Fund. A spread is the difference between the bid and ask prices for a security in the applicable marketplace, with respect to the execution of portfolio transactions. The spread will differ based upon various factors such as the type and liquidity of the security. Dealers, including CIBC WM and CIBC World Markets Corp., may furnish goods and services, other than order execution, to the Portfolio Advisor in partial exchange for processing trades through them (referred to in the industry as "soft dollar" arrangements). These goods and services are paid for with a portion of the brokerage commissions and assist the Portfolio Advisor with investment decision-making services for the Fund or relate directly to the execution of portfolio transactions on behalf of the Fund.

In addition, CIBC may enter into commission recapture arrangements with certain dealers with respect to the Fund. Any commission recaptured will be paid to the Fund.

During the period, the Fund paid brokerage commissions and other fees of \$3,882 to CIBC WM; the Fund did not pay any brokerage commissions or other fees to CIBC World Markets Corp. Spreads associated with fixed income and other securities are not ascertainable and, for that reason, cannot be included when determining these amounts.

Fund Transactions

The Fund may enter into one or more of the following transactions (referred to as the *Related Party Transactions*) in reliance on the standing instructions issued by the IRC:

- invest in or hold equity securities of CIBC or issuers related to a portfolio sub-advisor;
- invest in or hold non-exchange-traded debt securities of CIBC or an issuer related to CIBC, with terms-to-maturity of 365 days or more, issued in a primary offering and in the secondary market;
- make an investment in the securities of an issuer for which CIBC WM, CIBC World Markets Corp., or any affiliate of CIBC (referred to as a *Related Dealer*) acts as an underwriter during the offering of the securities or at any time during the 60-day period following the completion of the offering of such securities (in the case of a private placement offering, in accordance with the exemptive relief order granted by the Canadian securities regulatory authorities and in accordance with the policies and procedures relating to such investment);
- purchase equity or debt securities from or sell them to a Related Dealer, where it is acting as principal;
- undertake currency and currency derivative transactions where a Related Dealer is the counterparty;

- purchase securities from or sell securities to another investment fund or a managed account managed by the Manager or an affiliate; and
- engage in in-specie transfers by receiving portfolio securities from, or delivering portfolio securities to, a managed account or another investment fund managed by the Manager or an affiliate, in respect of a purchase or redemption on units in the fund, subject to certain conditions.

At least annually, the IRC reviews the Related Party Transactions for which they have issued standing instructions. The IRC is required to advise the Canadian securities regulatory authorities, after a matter has been referred or reported to the IRC by the Manager, if it determines that an investment decision was not made in accordance with a condition imposed by securities legislation or the IRC in any Related Party Transactions requiring its approval.

Custodian

CIBC Mellon Trust Company is the Fund's custodian (referred to as the *Custodian*). The Custodian holds all cash and securities for the Fund and ensures that those assets are kept separate from any other cash or securities that the Custodian might be holding. The Custodian also provides other services to the Fund including record-keeping and processing of foreign exchange transactions. The Custodian may hire sub-custodians for the Fund. The fees and spreads for services of the Custodian directly related to the execution of portfolio transactions by the Fund are paid by CAMI and/or dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Fund during that month. All other fees and spreads for the services of the Custodian are paid by the Manager and charged to the Fund on a recoverable basis. CIBC owns a 50% interest in the Custodian.

Service Provider

CIBC Mellon Global Securities Services Company (referred to as *CIBC GSS*) provides certain services to the Fund, including securities lending, fund accounting and reporting, and portfolio valuation. Such servicing fees are paid by the Manager, and charged to the Fund on a recoverable basis. CIBC indirectly owns a 50% interest in CIBC GSS.

Management Fees

The Fund, either directly or indirectly, pays CIBC an annual management fee to cover the costs of managing the Fund. Management fees are based on the Fund's net asset value and are calculated daily and paid monthly. Management fees are paid to CIBC in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, office overhead expenses and trailing commissions are paid by CIBC out of the management fees received from the Fund. The Fund is required to pay applicable taxes on the management fees paid to CIBC. Refer to the Simplified Prospectus for the annual management fee rate.

The following table shows a breakdown of the services received in consideration of the management fees, as a percentage of the management fees collected from the Fund for the period ended December 31, 2020. These amounts do not include waived fees or absorbed expenses.

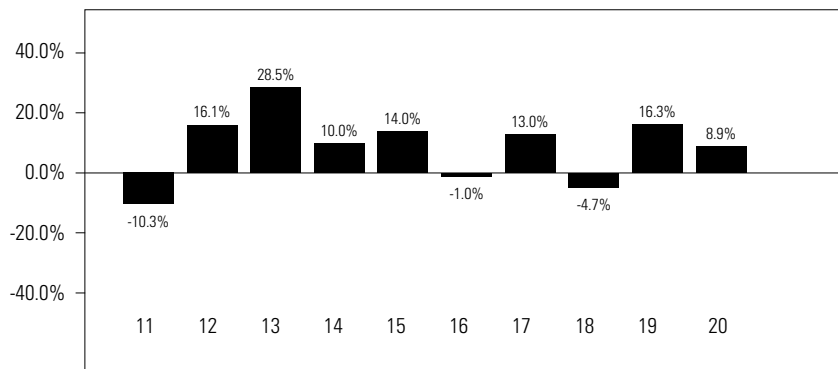

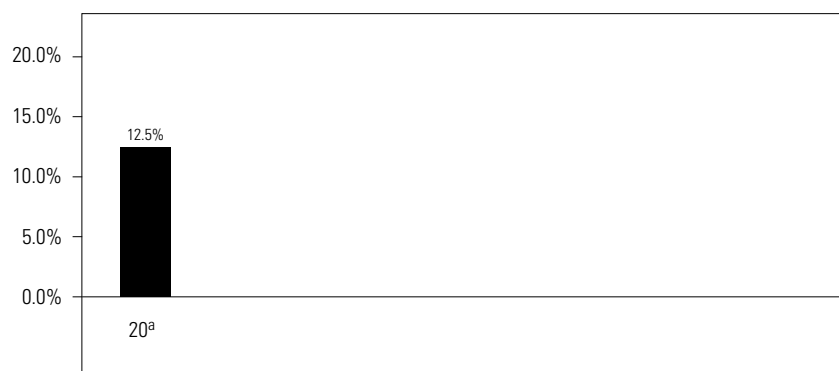
Year-by-Year Returns
