Management Discussion of Fund Performance

Investment Objective and Strategies

Investment Objective: CIBC U.S. Dollar Managed Growth Portfolio (the *Portfolio*) seeks to create a diversified portfolio by allocating its investments across a balanced blend of asset classes. Within the asset classes, the Portfolio will invest primarily in Mutual Funds including savings, income, and growth funds (the *Underlying Funds*). The Portfolio will focus primarily on long-term capital growth with a secondary focus on modest income generation.

The Portfolio will attempt to reduce its currency exposure to non-U.S. dollar currencies by implementing a currency hedging strategy that is aimed at protecting the Portfolio from non-U.S. dollar currency fluctuations in respect of units it owns in the Underlying Funds.

Investment Strategies: The Portfolio employs a long-term strategic asset mix weighting among the Underlying Funds of 20% income and 80% growth funds. While the asset mix of the Portfolio is not generally actively managed, a review and change of the strategic asset mix may be necessary in order to meet the investment objective. The Portfolio may also rebalance the mix of the Underlying Funds to realign the weightings within the strategic asset mix.

Risk

The Portfolio is a global equity balanced portfolio that is suitable for long-term investors who can tolerate medium investment risk.

For the period ended December 31, 2016, the Portfolio's overall level of risk remains as discussed in the simplified prospectus.

Results of Operations

The portfolio advisor of the Portfolio is CIBC Asset Management Inc. (CAMI or the *Portfolio Advisor*). The commentary that follows provides a summary of the results of operations for the period ended December 31, 2016. All dollar figures are expressed in thousands, unless otherwise indicated.

The Portfolio's net asset value decreased by 8% during the period, from \$27,930 as at December 31, 2015 to \$25,591 as at December 31, 2016. Net redemptions of \$4,161 were partially offset by positive

investment performance, resulting in an overall decrease in net asset value.

Class A units of the Portfolio posted a return of 7.9% for the period. The Portfolio's primary benchmark is the MSCI World Index (the *primary benchmark*), which returned 4.4% for the same period. The Portfolio's blended benchmark (the *blended benchmark*) comprises 23% S&P/TSX Composite Index, 19% S&P 500 Index (USD), 10% Barclays U.S. Corporate Investment Grade Bond (USD), 10% MSCI EAFE Index, 9% Russell 3000 Value Index (USD), 6% FTSE EPRA/NAREIT Developed Real Estate Index (Net), 6% MSCI Europe Index, 5% Citigroup World Government Bond Index, 5% FTSE TMX Canada Universe Bond Index, 4% MSCI Emerging Markets Index and 3% MSCI All Country Asia Pacific Index. The blended benchmark returned 9.2% for the same period. The blended benchmark closely reflects the asset classes in which the Portfolio invests. It will provide a more useful comparative to the performance of the Portfolio. The Portfolio's return is after the deduction of fees and expenses, unlike the primary and blended benchmarks. See *Past Performance* for the returns of other classes of units offered by the Portfolio.

The Portfolio has target allocations of 28.0% U.S. equities, 25.0% international equities, 23.0% Canadian equities, 15.0% global fixed income securities, 5.0% Canadian fixed income securities and 4.0% emerging markets equities.

The outcome of the U.S. presidential election resulted in a major market rotation in the U.S. equity market, as investors sought dividend-oriented stocks, as well as stocks more likely to benefit from the new administration's policy initiatives. Value-oriented stocks, particularly those generating high dividends, outperformed growth-oriented stocks by a wide margin across all market capitalizations.

International equity markets were affected by several events, including the U.K. vote to exit the European Union (*Brexit*) and the Italian referendum, which contributed to higher volatility and sector rotation. Higher-risk assets, which tend to be highly correlated with oil prices,

rose strongly from their first-quarter lows. Equity market performance was led by the energy, materials and industrials sectors.

Late in the year, the Organization of the Petroleum Exporting Countries agreed to cut oil production, causing energy prices to recover from early-year lows. As a result, the Canadian equity market posted strong returns, led primarily by the materials and energy sectors. Rising commodity prices were also reflected in bank stock performance.

In global fixed income markets, longer-term sovereign bond yields, irrespective of quality, fell leading up to and after *Brexit*. The U.S. Federal Reserve Board raised interest rates, while some other global central banks lowered their rates into negative territory.

In Canada, corporate bonds outperformed as investors sought higher-yielding alternatives to government bonds. Emerging market equities benefited from a weakening U.S. dollar, stabilizing commodity prices and a less negative outlook for the Chinese economy.

From an underlying fund perspective, Renaissance U.S. Dollar Corporate Bond Fund was the most significant contributor to the Portfolio's performance relative to the blended benchmark, followed by Renaissance U.S. Equity Income Fund (USD) and CIBC Global Bond Fund.

Underlying fund CIBC International Equity Fund was the most significant detractor from the Portfolio's relative performance, followed by CIBC European Equity Fund and CIBC U.S. Equity Fund (USD).

Recent Developments

Effective September 6, 2016, the maximum annual trailing commission was reduced from 1.20% to 1.00% for Class A, Class T4, Class T6 and Class T8 units of the Portfolio.

Effective April 27, 2016, the composition of the Independent Review Committee (*IRC*) changed. John Crow resigned his position as member and Chair. Marcia Lewis Brown was appointed as member and Don Hunter was appointed as Chair.

Related Party Transactions

Canadian Imperial Bank of Commerce (*CIBC*) and its affiliates have the following roles and responsibilities with respect to the Portfolio, and receive the fees described below in connection with their roles and responsibilities.

Manager

CIBC is the Manager of the Portfolio. The Portfolio holds units of other mutual funds (the *Underlying Funds*), which may also be managed by CIBC or its affiliates. CIBC receives management fees with respect to the day-to-day business and operations of the Portfolio, calculated based on the net asset value of each respective class of units of the Portfolio as described in the section entitled *Management Fees*. The Manager also compensates its wholesalers in connection with their marketing activities regarding the Portfolio. From time to time, CIBC may provide seed capital to the Portfolio.

Trustee

CIBC Trust Corporation, a wholly-owned subsidiary of CIBC, is the trustee (the *Trustee*) of the Portfolio. The Trustee holds title to the property (cash and securities) of the Portfolio on behalf of its unitholders.

Portfolio Advisor

The portfolio advisor provides, or arranges to provide, investment advice and portfolio management services to the Portfolio. CAMI, a wholly-owned subsidiary of CIBC, is the portfolio advisor of the Portfolio.

Distributor

Dealers and other firms sell the units of the Portfolio to investors. These dealers and other firms include CIBC's related dealers such as the principal distributor, CIBC Securities Inc. (*CIBC SI*), the CIBC Investor's Edge discount brokerage division of CIBC Investor Services Inc. (*CIBC ISI*), the CIBC Imperial Service division of CIBC ISI, and the CIBC Wood Gundy division of CIBC World Markets Inc. (*CIBC WM*). CIBC SI, CIBC ISI, and CIBC WM are wholly-owned subsidiaries of CIBC.

CIBC may pay trailing commissions to these dealers and firms in connection with the sale of units of the Portfolio. These dealers and other firms may pay a portion of these trailing commissions to their advisors who sell units of the Portfolio to investors.

Brokerage Arrangements and Soft Dollars

The Portfolio Advisor purchases and sells units of the Underlying Funds on behalf of the Portfolio and, as a result, the Portfolio does not incur any sales charges or brokerage commissions with respect to execution of portfolio transactions of the Underlying Funds.

The Portfolio may also enter into non-U.S. currency hedging transactions, involving the use of derivatives such as options, futures, forward contracts, swaps, and other similar instruments. Although it is not expected that there will be brokerage arrangements in connection with the non-U.S. currency hedging transactions, if that were to occur, the Portfolio would be responsible for any brokerage fees and commissions with respect to such transactions. CIBC WM and CIBC World Markets Corp., each a subsidiary of CIBC, are dealers through which execution of these non-U.S. currency hedging transactions may take place.

Decisions that the Portfolio Advisor may make as to brokerage transactions, including the selection of markets and dealers and the negotiation of commissions, would be based on elements such as price, speed of execution, certainty of execution, and total transaction costs.

CIBC WM and CIBC World Markets Corp. may also earn spreads on the sale of securities to the Portfolio. A spread is the difference between the bid and ask prices for a security in the applicable marketplace, with respect to the execution of portfolio transactions. The spread will differ based upon various factors such as the type and liquidity of the security.

Dealers, including CIBC WM and CIBC World Markets Corp., may furnish goods and services, other than order execution, to the Portfolio Advisor in partial exchange for processing trades through them (referred to in the industry as “soft dollar” arrangements). These goods and services are paid for with a portion of the brokerage commissions and assist the Portfolio Advisor with investment decision-making services for the Portfolio or relate directly to the execution of trades on behalf of the Portfolio.

In addition, CIBC may enter into commission recapture arrangements with certain dealers with respect to the Portfolio. Any commission recaptured will be paid to the Portfolio.

During the period, the Portfolio did not pay any brokerage commissions or other fees to CIBC WM or CIBC World Markets Corp. Spreads associated with fixed income and other securities are not ascertainable and, for that reason, cannot be included when determining these amounts.

Custodian

CIBC Mellon Trust Company is the custodian of the Portfolio (the *Custodian*). The Custodian holds all cash and securities for the Portfolio and ensures that those assets are kept separate from any other cash or securities that the Custodian might be holding. The Custodian also provides other services to the Portfolio including record-keeping and processing of foreign exchange transactions. The Custodian may hire sub-custodians for the Portfolio. The fees and spreads for services of the Custodian directly related to the execution of portfolio transactions by the Portfolio are paid by CAMI and/or dealer(s) directed by CAMI, up to the amount of the credits generated under soft dollar arrangements from trading on behalf of the Portfolio during that month. All other fees and spreads for the services of the Custodian are paid by the Manager and charged to the Portfolio on a recoverable basis. CIBC owns a 50% interest in the Custodian.

Service Provider

CIBC Mellon Global Securities Services Company (*CIBC GSS*) provides certain services to the Portfolio, including fund accounting and reporting, securities lending, and portfolio valuation. Such servicing fees are paid by the Manager and charged to the Portfolio on a recoverable basis. CIBC indirectly owns 50% interest in CIBC GSS.

Previously, the Portfolio prepared its financial statements in accordance with Canadian Generally Accepted Accounting Principles (GAAP) as defined in Part V of the CPA Canada Handbook. Under Canadian GAAP, the Portfolio measured fair values of its investments in accordance with CICA Handbook Section 3855 which required the use of bid prices for long positions and ask prices for short positions. As such, the net assets per unit figure presented in the financial statements may differ from the net asset value calculated for fund pricing purposes. An explanation of these differences can be found in the notes to the financial statements issued prior to January 1, 2014. Upon adoption of IFRS, the Portfolio measures the fair value of its investments by using the close market prices, where the close market price falls within the bid-ask spread. As such, the Portfolio's accounting policies for measuring the fair value of investments in the financial statements are consistent with those used in measuring the net asset value for transactions with unitholders. Accordingly, the opening net asset figure as at January 1, 2013 was restated to reflect accounting policy adjustments made in accordance with IFRS. All figures presented for periods prior to January 1, 2013 were prepared in accordance with Canadian GAAP and subsequent thereto were prepared in accordance with IFRS.

⁸ The portfolio turnover rate indicates how actively the portfolio advisor and/or portfolio sub-advisor manages the portfolio investments. A portfolio turnover rate of 100% is equivalent to a fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a portfolio turnover rate in a period, the greater the trading costs payable by a fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The Portfolio, either directly or indirectly, pays an annual management fee to CIBC to cover the costs of managing the Portfolio. Management fees are based on the net asset value of the Portfolio and are calculated daily and paid monthly. Management fees are paid to CIBC in consideration for providing, or arranging for the provision of, management, distribution, and portfolio advisory services. Advertising and promotional expenses, office overhead expenses, trailing commissions, and the fees of the portfolio sub-advisor(s) are paid by CIBC out of the management fees received from the Portfolio. The Portfolio is required to pay applicable taxes on the management fees paid to CIBC. Refer to the Simplified Prospectus for the maximum annual management fee rate for each class of units.

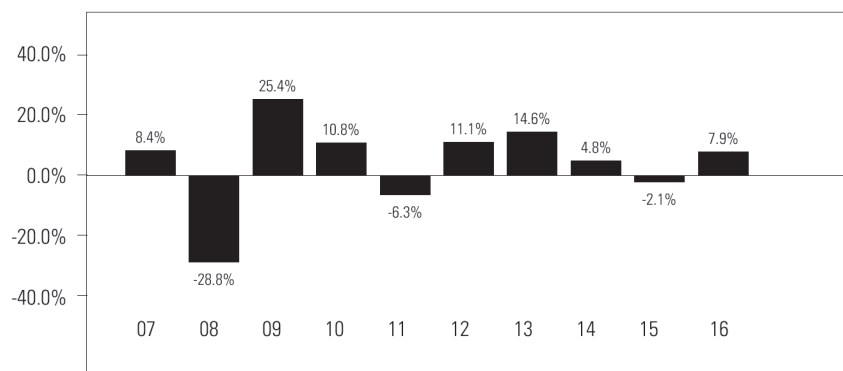

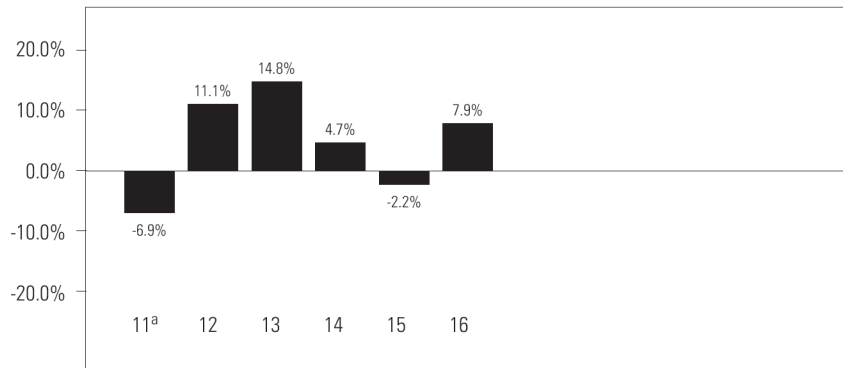
Year-by-Year Returns

Class T4 Units



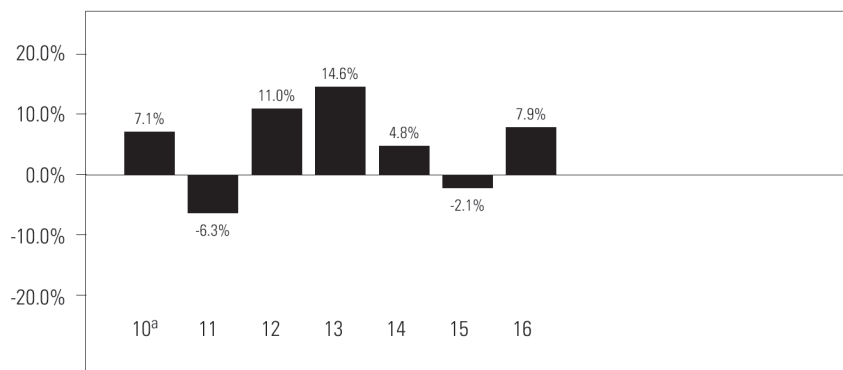

MSCI Europe Index is a free float-adjusted market capitalization index that is designed to measure developed market equity performance in Europe.

MSCI World Index is a free float-adjusted market capitalization index composed of companies representative of the market structure of developed market countries in North America, Europe and the Asia/Pacific region.

Russell 3000 Value Index (USD) measures the performance of the broad value segment of U.S. equity value universe. It includes those Russell 3000 companies with lower price-to-book ratios and lower forecasted growth values.

S&P 500 Index (USD) is a capitalization-weighted index of 500 stocks, designed to measure performance of the broad U.S. economy representing all major industries.
