

CIBC 12 Days of Winning Contest - Official Rules

1. Contest Period

The CIBC 12 Days of Winning Contest (the "Contest") begins at 12:01 a.m. Eastern Time ("ET") on November 21, 2018 and ends at 11:59 p.m. on December 24, 2018 (the "Contest Period"). By participating in the Contest, each entrant agrees to abide by and be bound by these Official Rules. Entrants further agree to abide by and be bound by all decisions of Canadian Imperial Bank of Commerce ("CIBC", or the "Sponsor"), which shall be final and binding, without right of appeal, in all matters relating to this Contest and the awarding of the prize(s), including without limitation eligibility and/or disqualification of entries.

2. Eligibility

The Contest is open to legal residents of Canada (excluding Quebec) who have reached the age of majority in their jurisdiction of residence as of the date of entry. Excluded from eligibility are the officers, directors, employees, agents and representatives of Sponsor, any Contest judges, and each of their respective parents, subsidiaries, affiliates, advertising and promotion agencies (collectively, the "**Promotion Entities**"), and members of the immediate families (defined as parents, siblings, children and spouses, regardless of where they live) or households (whether or not related) of such officers, directors, employees, agents and representatives.

3. How to Enter

NO PURCHASE NECESSARY. To receive one (1) automatic entry in the Contest, CIBC customers may log in to their CIBC Online Banking or CIBC Mobile Banking App, or visit any participating CIBC banking centre in Canada (excluding Quebec), and complete at least one (1) Global Money Transfer during the Contest Period and using the promo code HOLIDAY18.

If an entrant does not want to be automatically entered into the Contest, send an email to GMTContestUnsub@cibc.com with "NO ENTRY" as the subject, and your full name and mailing address in the body of the email, and Sponsor will remove any entry from this Contest you were otherwise eligible to receive.

To obtain one (1) entry without completing a Global Money Transfer, send an original 50-100 word essay during the Contest Period on "How you celebrate the holidays" and type your first name, last name, phone number, age, province and mailing address and email the information to: **gmt@cibc.com**. Email entries that are automatically reproduced or made in any fashion other than as specified herein are void.

<u>Limit</u>: of ten (10) entries per person per calendar day ET during the Contest Period, regardless of method of entry.

4. Prize

There are twelve (12) prizes available to be won, each consisting of \$1,000 CAD, to be deposited into selected entrants' bank account.

Prize must be accepted as awarded and may not be substituted, transferred or otherwise, except at Sponsor's sole discretion. Sponsor reserves the right, at its sole discretion, to substitute a prize of greater or equivalent monetary value if a prize cannot be awarded as described for any reason. Prizes will be delivered to verified winners only to one (1) address in Canada. Sponsor will not replace any lost or stolen prizes. Any other costs or expenses associated with the prizes not specified herein will be the responsibility of selected winners.

5. Winner Selection

On or about the following dates at 12:00 p.m. ET at the offices of The Marco Corporation, a random draw will be conducted from among all eligible entries received during the applicable Entry Period for the purpose of selecting twelve (12) potential winners (subject to satisfying the prize claim conditions below). Odds of being selected depend on the number of eligible entries received during the applicable Entry Period.

6. Selected Entrant Verification and Prize Claim Conditions

Selected entrants will be notified by telephone or email at the telephone number or email address provided at the time of entry or associated with the CIBC account of the selected entrant. In order to be declared a winner, selected entrant must: (i) respond to notification of selection within five (5) business days of first attempt by Sponsor; (ii) correctly answer a time-limited mathematical skill-testing question to be

administered by telephone at a mutually convenient time; (iii) sign and return to Sponsor, within three (3) business days of it being sent by Sponsor, a written declaration and release form, releasing the Promotion Entities from any liability in connection with this Contest or the use, misuse, awarding or possession of any prize (the "Release"); and, (iv) otherwise comply with these Official Rules.

Return of any prize or winner notification as undeliverable, inability to reach selected entrant or failure of selected entrant to respond to notification within five (5) business days of first attempt by Sponsor or Sponsor's agent, failure to provide proof of eligibility (if requested), release documents, or other required documentation in a timely manner, failure to correctly answer the skill-testing question, or other non-compliance with these Official Rules may result in disqualification, forfeiture of the prize and, at Sponsor's sole discretion, selection of an alternate eligible entrant for the forfeited prize in accordance with these Official Rules, who will be subject to disqualification in the same manner.

7. Right to Void / Terminate / Suspend / Modify

Sponsor reserves the right to terminate, suspend or modify this Contest, in whole or in part, at any time and without notice or obligation if, in Sponsor's sole discretion, any factor interferes with its proper conduct as contemplated by these Official Rules. Without limiting the generality of the foregoing, if the Contest, or any part thereof, is not capable of running as planned for any reason, including but not limited to infection by computer virus, bugs, tampering, unauthorized intervention, fraud, programming errors, or technical failures, which, in the sole discretion of Sponsor, corrupt or affect the administration, security, fairness, integrity or proper conduct of this Contest, Sponsor may, in its sole discretion and void any suspect entries and: (a) terminate the Contest, or any portion thereof; (b) modify or suspend the Contest, or any portion thereof, to address the impairment and then resume the Contest, or relevant portion, in a manner that best conforms to the spirit of these Official Rules; and/or (c) award the prizes from among the eligible, nonsuspect entries received up to the time of the impairment in accordance with the winner selection criteria discussed above.

Sponsor reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the entry process, the operation of the Contest, violates the Official Rules, or acts with intent to annoy, abuse, threaten or harass any other person.

8. Limitation of Liability and Releases

By participating in this contest, entrants agree that sponsor, contest judges and the promotion entities have no liability whatsoever for, and shall be held harmless by entrants against, any liability for any injuries, losses or damages of any kind (including direct, indirect, incidental, consequential or punitive damages) to persons or property resulting from the contest, including the acceptance, possession, misuse or use of the prize, or the merchandise for which it is redeemed (if applicable). Sponsor and its authorized agents will collect, use, and disclose the personal information you provide when you enter the Contest for the purposes of administering the Contest and prize fulfillment. You may be offered the opportunity to receive additional communications from Sponsor or its partners about its products, and upcoming contests and promotions. Your decision whether or not to receive such communications will not affect your chances of winning. All entries and prize claims are subject to verification. Proof of entry submission does not constitute proof of receipt. Entrants agree to abide by these Official Rules. Decisions of Sponsor and/or any independent Contest judging organization will be final and binding on all matters pertaining to this Contest. Contest is subject to all applicable federal, provincial and municipal laws. Void where prohibited. Sponsor reserves the right to correct any typographical, printing, computer programming or operator errors. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. The invalidity or

unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. If any provision of the Official Rules is determined to be invalid or otherwise unenforceable, then the Official Rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein. The Sponsor reserves the right, in its sole and absolute discretion, to administer an alternate test of skill as it deems appropriate or necessary to comply with applicable law. Should a winner make any false statement(s) in any document referenced above, the winner may be required to promptly return to Sponsor his/her prize, or the cash value thereof. Warning: any attempt by an entrant or any other individual to deliberately damage or undermine the legitimate operation of the contest is a violation of criminal and civil laws, and sponsor reserves the right to prosecute and seek damages to the fullest extent permitted by law.

In the event of a dispute as to the identity of the person who submitted any entry, the authorized account holder of the e-mail address submitted at registration will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an e-mail address by an access provider, service provider, or other person or organization responsible for assigning e-mail addresses for the account associated with the submitted address. The potential winner may be required to show proof of being the authorized account holder.
